• The Governing Council of the institution consists of the Hon'ble Vice Chancellor, Karnatak University, Dharwad, as Chairman, Registrar of the University, one Syndicate member, two senior Associate Professors, and one Senior Assistant Professor as members, with the Principal of the College serving as Secretary.

Principal and other faculty are responsible for planning and policy development, institutional budget, academic and research growth of the institute, and other extension activities. The Principal directs departmental heads to prepare the annual departmental budget. The HoD submits requirements along with relevant quotations, depending upon the syllabus's needs and current industry trends. For the acquisition of goods and services, including requisition preparation, funds requirement, and follow-up inquiries, the college practices decentralization by providing operational autonomy to the departments.

Furthermore, the HoD prepares a consolidated report and submits it to the Principal for approval. The Principal consolidates the requirements of all departments and forwards them to the University authorities for approval. The sanctioned budget from the University is received by the institute.



- Acting as a liaison to the College Principal in investigating incidents of violations of disciplinary rules occurring in the college.
- Encouraging individual and small group discussions about challenging behavior with stakeholders.

Anti-Ragging Cell:

According to the Hon'ble Supreme Court of India, "Ragging is any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating, or handling with rudeness to any student, indulging in rowdy or undisciplined activities which cause or are likely to cause annoyance, hardship, or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student and which has the effect of causing or generating a sense of shame or embarrassment to adversely affect the psyche of a fresher or a junior student."

To ensure a completely ragging-free environment on the campus and in compliance with the letter from UGC, an Anti-Ragging Cell has been constituted in the college campus.
